**MEMORANDUM FOR RECORD**

17 December 2007

**SUBJECT:** Player Contract

This contract is an agreement between \_\_\_\_\_, herein after referred to as Player, and the Mt. Carmel FIRE, herein after referred to as Team.

Team hereby offers a roster position to Player, and Player hereby accepts such position and agrees to abide by the following:

**PARTICIPATION:**

1. Player agrees to attend all practices and games for the duration of the season. Practices will also be conducted in the off season and require attendance. Anyone that misses 3 consecutive practices, any one game, or any one scrimmage, will be removed from the team at the Team's discretion.
2. Player agrees to be bound by this contract to the Team until removal from the team or termination of contract by the Team. Player agrees that he is not currently contracted by any other team and that he will not be contracted by another team without official termination of contract by the Mt. Carmel FIRE.
3. There are exceptions to the attendance policy, as follows:
  - ? Prior approval by the Head Coach.
  - ? Prior approval by a Team Owner.
4. The Team will also conduct community service operations at random. These require attendance unless otherwise approved by the above authorities.

**DISCIPLINE**

1. Player agrees to always be on time to practice, scrimmages, games, and travel for games. These times will be set forth by either the Head Coach or a Team Owner.
2. If Player is late for a game or scrimmage, Player will sit out entire game or scrimmage, but will be required to be on the sideline for the length of the game, at the Team's discretion. Failure to do so will result in possible removal from the Team.
3. There will be zero tolerance by the Team for any disrespectful behavior by Player. This includes, but is not limited to: use of foul language, vulgarities, or threats at any Team practice, game, or other Team event; talking back to or disrespecting any Team staff member or Team Captain; unsportsmanlike conduct towards any teammate or opponent. There will be zero tolerance towards any type of behavior that negatively impacts the image, reputation, or mission of the Team. Failure to comply will result in removal from Team at the Team's discretion.

**EQUIPMENT RESPONSIBILITY**

1. Player agrees to be responsible for all equipment issued to Player by the Team. Player is responsible for general upkeep and cleaning.
2. All equipment issued to Player by the Team is to be returned by Player upon removal from the Team, or finish of the season. Failure to do so will result in litigation to obtain MSRP of all equipment not returned.
3. Player is responsible for the cost of items discussed on the Equipment Responsibility form. These items may be purchased through the team account but will be paid for by Player.
4. Personal equipment items, such as cleats, athletic supporter, etc., will be obtained without team assistance and paid for by Player.

**EXPENSES**

1. All expenses incurred by Player for transportation to practices, home games, and home scrimmages, are the responsibility of the Player and are not reimbursable by the Team.
2. For away games and away scrimmages, the Team may obtain a charter bus and the cost will be split between all team members. Player will be responsible for his portion per trip. This will considerably reduce the per player cost for such trips.
3. As discussed above, Player will be responsible for costs of some equipment not provided by the Team.
4. Player will also assume responsibility for the cost of health insurance. This is not mandatory but is highly recommended.

**PLAYER AGREEMENT**
